Processing of personal data

This page describes the procedures used to process personal data of users visiting this website. This privacy policy is provided pursuant to art. 13 of the Law Decree No. 196/2003 - Privacy Policy Statement for users of interactive web services accessible electronically at the following address: www.orebsi.it

The privacy policy does not apply to other websites that may be browsed via links. This privacy policy is also based on Recommendation No. 2/2001 issued by the European authorities for the protection of personal data, grouped according to art. 29 of the European Directive No. 95/46/EC, and adopted on May 17, 2001 to identify the minimum requirements for the collection of personal data online, and, in particular, the procedures, time frames and nature of the information that the data controller must provide to users when connecting to the web, independently from the purposes of connection.

Data controller

Data related to individuals who are identified or can be identified, may be processed as a result of browsing this website.

Data processing location

Data processing related to web services offered through this website is carried out at OREB SISTEMI INDUSTRIALI srl and handled only by technical personnel of the Data Processing Department authorized for it, or by other parties occasionally authorized for maintenance operations. No data originating from the web service provided is communicated or divulged. Personal data provided by users who request information material (bulletins, CD-ROMs, newsletters, annual reports, answers to questions, acts and provisions, etc.) are used only to perform the service or the requested task and will be disclosed to third parties only if necessary to that end.

Types of data processed

Navigation Data

Computer systems and software procedures used to operate this website acquire, during their normal operation, personal data which transmission is implicit in the use of the Internet communication protocols. This information is not collected to be associated to specific identified individuals, but it is such that by its nature could, through processing and association with data held by third parties, allow identifying the users. This category of data includes IP addresses, or domain names of computers used by users connecting to the site, URI (Uniform Resource Identifier) addresses of the requested resources, time of the request, method used to submit the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response provided by the server (successful, error, etc.) and other parameters regarding the operating system and user's computer environment. These data are used only to obtain anonymous statistical information about the site and to check its correct operation and they are deleted immediately after processing. The data could be used to determine responsibility in case of hypothetical computer crimes against the website: without prejudice to this possibility, the data on web contacts are not kept for more than seven days.

Data supplied voluntarily by the user

The optional, explicit and voluntary sending of e-mails to the addresses shown on this website involves the subsequent acquisition of the sender's address, needed to answer the requests, as well as any other personal data included in the message. Specific summary information will be progressively reported or displayed on the website pages dedicated to special on-request services.

Cookies

No user's personal data is acquired from the site. No cookies are used to transmit personal information and no permanent cookies are used, or user's tracking systems. The use of session cookies (which are not permanently stored on the user's computer and disappear when the browser is closed) is strictly limited to the transmission of session identifiers (constituted by random numbers generated by the server) necessary to enable a safe and efficient website browsing. The session cookies used on this website prevent the use of other computer technologies that could potentially compromise the confidentiality of user's navigation and they do not allow the acquisition of personal data that may identify the user.

Non-mandatory nature of providing data

Aside from what has been specified on navigation data, users may provide personal data on their free will to fill out request forms or contact forms to request informative material or send other communications. Failure to provide such data may lead to the impossibility of obtaining what has been requested. Finally, it should be reminded that in some cases (not part of the ordinary management of this website) the Public Authority may request news and information according to article 157 of the Law Decree No. 196/2003, in order to verify the processing of personal data. In these cases, a response is mandatory to avoid an administrative fine.

Data processing method

Personal data are processed using automated tools for the time strictly necessary to achieve the purposes for which they have been collected. Specific safety measures are taken to prevent loss of data, misuse, improper or unauthorized access.

Rights of the interested parties

The individuals to whom the personal data refer, have the right at any time to obtain confirmation of the existence of the data, be aware of their content and origin, verify their accuracy or request their integration, updating, or correction (art. 7 of L.D. No. 196/2003). Pursuant to the same article, they also have the right to request cancellation, transformation into anonymous form or the blocking of data processed in violation of the law, and to oppose in any case, for legitimate reasons, their processing. The requests must be addressed to the Data Processing Controller.
